OUTDOOR AUTOJUMBLE STANDS

Outdoor Autojumble stand space is sold in units of 6ft frontage x 30ft depth. Camping is permitted on-site at no extra charge. The plots will be allocated on a 'first come – first served' basis. The charges include both days of the show.
Note: No discount is available for attendance on only one day of the Show.

STAND COSTS

The smallest size of plot that we sell is 12ft frontage x 30ft depth at a price of £25. Additional space increases in size in units of 6 ft. For each additional 6ft of frontage booked, the additional charge is £15.

12ft frontage = £25, 18ft frontage = £40, 24 ft frontage = £55, 30ft frontage = £70, 36 ft Frontage = £85, for an even larger stand space please ask for a quotation.

Newark Kit Car Show - Rules and Regulations Autojumble Section

1. Definitions

In these rules and regulations the term exhibitor refers to all traders booking an autojumbler plot and includes all employees or agents of such. The term Organiser shall mean Newark Promotions. The term Show shall mean The Newark Kit Car Show and plot shall mean the Exhibitors stand space.

2. Application for autojumble plots

Application for autojumble plots must be made on the forms provided by the Organisers, must be signed by a responsible person.

3. Allocation of autojumble plots

Plots will be allocated by the Organisers in order of receipt of applications and, wherever possible, in accordance with Exhibitor's choice and preference.

4. Payment

Payment must be made in full for the autojumble plot(s) applied for, and must be forwarded with the signed booking form.

5. Revision of layout

Should it be necessary to revise the layout of the Showground, for any purpose, the Organisers reserve the right to transfer an Exhibitor to an alternative mutually agreeable site. In the event of the Autojumble Village site being sold out, late bookers will be offered an alternative location. This site may not be in such a prime position.

6. Fire precautions

Exhibitors must adhere to all fire and safety regulations which affect the Show.

7. Passes and tickets

Passes are not transferable and no Exhibitor will be admitted without such pass being produced on entering the Showground entrance.

8. Advertised attractions

The Organisers reserve the right to amend or cancel any part of the advertised attractions.

The decision of the Organisers shall be final.

9. Exhibitors liabilities

Exhibitors should arrange appropriate third party liability insurance.

The Organisers will not be responsible for the safety of any exhibit or for loss by theft or destruction by fire or any other cause not within the control of the Organisers.

All exhibits and plots must be properly protected so as to avoid danger to any person or persons visiting or taking part in the show. The Organisers shall be indemnified by the Exhibitor against any claim or action on account of any injury or damage being caused, or occasioned by any exhibit to any person whatsoever.

Every Exhibitor hereby accepts liability for all acts or omissions of himself, his staff, and undertakes to indemnify the Organisers and keep them indemnified against all liability in respect thereof and against all actions, suits, proceedings, claims, demands, costs and expenses whatsoever, which may be taken or made against the Organisers or incurred or become payable by them arising therefrom or in respect thereof including any claims arising out of the supply by the Exhibitor of goods of any kind whatsoever whether such goods be sold or given away free and including any legal costs and expenses and any compensation and other costs paid by the organisers to compromise or settle any such claims.
